our role as teachers of Torah to make our feelings and opinions known to the public at large and we ask you to explore every possible avenue to obviate this blemish.

Notwithstanding the fact that these gay-lesbian organizations attract very few people on campus and that the university gives them neither support nor recognition, we regard their very existence as distinct groups an offense against all that we and the institution stand for. We cannot accept, and indeed we unambiguously deplore, people gathering to proclaim their defiance of the Torah's injunction against homosexuality, part of the divine moral code that has guided Western society for three and a half millennia. What Judaism tells us is an abomination should find no welcome in our institution and, indeed, in any academic institution which retains even a minimum

commitment to morality.
